Patrinos has over a decade of experience in the private equity space. At HarbourVest Partners, she was a member of the investment team, investing in buyout, venture, credit, distressed and infrastructure fund managers. Most recently, she managed her own private equity consulting practice advising

institutional clients on secondary transactions, fund structuring and portfolio valuation. During her years at HarbourVest and later as a consultant, she invested and advised on over \$900 million in private equity fund interests. Patrinos began her career at Citigroup in New York where she was a founding member of the infrastructure M&A practice, advising private equity clients, listed fund managers and alternative asset fund managers on multi-billion dollar acquisitions and divestitures.
